#### 9.) Boards and Committees

#### 10.) Councillor Reports

#### a) Blue Green Algae

Deputy Mayor Durocher stated that he had read an article in the Toledo Blade that Ohio State would be investing in finding and fighting the sources of blue green algae.

## b) Back-up Generator

Mayor Masse stated that through contact with Hydro One the back-up generator would be left on the Island this winter, but due to their purchase policies and procedures they would not be putting it in writing.

#### c) Winter Air Service

The Mayor stated that Owen Sound Transportation awarded the winter air service contact to Cameron Air again this year and would be secured for the next two years. He also stated that Cameron Air has done a great job in servicing our community.

#### d) MNR Meeting

The Mayor stated that he and the CAO had attended a meeting with MNR to discuss concerns within the community, one being having a wheelchair accessible trail to the Lighthouse. The Mayor went on to state that the response was that the project would likely go to tender in 2016.

The Mayor continued with the next order of business discussed at the meeting, concerning the Environmental Advisory Committee that must be formed in conjunction with the Zoning By-Law and Official Plan. The Mayor commented that MNR had committee members together and are now waiting on the Township to present representatives, which would have to take place after the election.

The Mayor also stated that the hunt proposal that was sent in was discussed and it was not guaranteed that it would go through, but it looks favorable and should be decided by the summer.

### e) RFP for Audit Services

The CAO addressed the RFP for Audit services and stated the request date has now ended and a decision has to be reached quickly, he went on to state that a report would be sent by email and then voted on.
